**THE TITLE OF THE TENDER:**

1. The Ebonyi State Government through the state Ministry of Health is desirous to undertake the Supply of Hospital and Medical Laboratory Experiments for the Fourteenth (14) General Hospitals in Ebonyi State.

Login to your account, click Tender Advertisement. You will see all published tenders on a table.

On the table, Click on the Tender/project you wish to make payment for and it will open the Tender Advertisement Details page for that Tender/project.

On the Tender Advertisement Details page for the selected Tender, you will see Payment link at the bottom. Click on the link and make online card payment.

### **3. ELIGIBILITY REQUIREMENTS**

All interested bidders must visit [www.ebonyieprocure.eb.gov.ng](http://www.ebonyieprocure.eb.gov.ng) to register their company (if you have not registered before) and upload the following documents:

- a) Company's certificate of Incorporation with (CAC)
- b) Company's Registration with Ebonyi State Ministry of Works Contractor's Registration in Category "D" current at the time of the tender
- c) List of Plant, Equipment and Technical Staff available for the project
- d) Evidence of Current Tax Clearance Certificate for the past three years
- e) Evidence of VAT Certificate and VAT remittances to Federal Inland Revenue Service
- f) Evidence of similar projects undertaken in the past three years including scope, site of project, contract sum and evidence of successful completion of the project
- g) Evidence of current Audited Accounts of the company for the last three years
- h) Evidence of financial capability and bank reference

### **4. METHOD OF SUBMISSION**

Technical and Financial Bids must be submitted through the Contractors/Suppliers dashboard in the Ebonyi State E-Procurement System.

### **5. GENERAL INFORMATION**

- a) The Ministry may verify any or all the claims made by applicants and shall disqualify any company whose claims are found to be false.
- b) Contractors who have worked for the ministry and have history of poor performances, abandonment, termination and/or prolong contract period need not apply.
- c) Contractors who have capacity and capability to commence and complete any of the projects before payment is scheduled, are requested to state it clearly in the building document.
- d) Non compliance to the instructions will lead to disqualification.
- e) Bid Documents in English will be obtained from the **Ebonyi state e- Procurement system** ([www.ebonyieprocure.eb.gov.ng](http://www.ebonyieprocure.eb.gov.ng)) after completion of registration and Tender fee payment on the portal.
- f) All bids will be submitted through the E-Procurement system as mentioned above before the bid submission deadline of Friday 6<sup>th</sup> October, 2023 at 1:00pm Nigeria time. Late bids will not be accepted by the system.
- g) Bids will be opened virtually shortly after the close of tender on Friday 6<sup>th</sup> October at 1:00 pm, Nigeria time.
- h) Any prospective bidder from their dashboard messaging tool, may ask the procuring entity to provide explanations as to the content of the tender

document from now till one week of the deadline period for the submission of tenders as of the date of tender notice publication.

- i) The Council is not bound to accept the lowest or any tender.
- j) Bidding will be conducted in accordance with the Law governing Public Procurement.
