## **THE TITLE OF THE TENDER:**

## 2. Scope of Work

The scope of works essentially involves Road Survey, design and preparation of detailed drawings for the road, drainage, culverts and bridges (if any).

- **3.** Tenders are hereby invited from reputable consultants who must have registered with CAC and Ebonyi State Ministry of Works category (D) current at the time of tender. Furthermore, applicants shall meet the following prequalification criteria:
  - i. A substantial evidence of carrying out such work for the last three to five years
  - ii. Provide evidence of tax clearance
  - iii. Evidence that the contractor has equipment and personnel to execute such road design work.

- **4.** Prequalification documents from interested consultants must be submitted through the Ebonyi State E-Procurement System. Tenders must be submitted not later than 14 days from the date of this advertisement (i.e; 1:00pm on 12<sup>th</sup> September, 2023 is the submission deadline).
- **5.** Only the prequalified consultants shall be invited to submit financial bids for the road survey and design as designated and shall make a non-refundable payment of fifty thousand naira (N50,000) only per Lot in accounts department of the state Ministry of Infrastructural Development for Concession.
