

# **INVITATION TO TENDER**

## MINISTRY OF INFRASTRUCTURAL DEVELOPMENT FOR CONCESSION Centenary City, Abakaliki, Ebonyi State

#### THE TITLE OF THE TENDER:

- 1. The Ebonyi State Government through the state Ministry of Infrastructural Development for Concession is desirous to undertake the following projects:
  - i. CONSTRUCTION OF ABAOFIA MARKET SHADE UKPA -ONUBORHLE ECHIABA ROAD WITH SPUR TO JUDGES QUARTERS (5.353 KM), EBONYI LGA, EBONYI STATE
  - ii. CONSTRUCTION OF ST MARY'S CATHOLIC CHURCH OBEGU ABOFIA ECHIABA DEVELOPMENT CENTER ROAD (3.55KM) EBONYI LGA, EBONYI STATE
  - iii. CONSTRUCTION OF ST ANTHONY'S CATHOLIC CHURCH AGHAMEHU VILLAGE HEALTH CENTER - ABOFIA ROAD (3.84KM), EBONYI LGA, EBONYI STATE

Tenders are hereby invited from interested reputable Contractors who wish to bid for the project. Tender documents for the project will be obtained from the Ebonyi State e-Procurement System after the payment of non-refundable deposit of one hundred thousand naira (N100,000.00) only.

Login to your e-Procurement account, click Tender Advertisement on the MENU. You will see all published tenders on a table.

On the table, Click on the Tender/project you wish to make payment for and it will open the Tender Advertisement Details page for that Tender/project.

On the Tender Advertisement Details page for the selected Tender, you will see Payment link at the bottom. Click on the link and make online card payment.

## iv. ELIGIBILITY REQUIREMENTS

All interested bidders must visit <u>www.ebonyieprocure.eb.gov.ng</u> to register their company (if you have nor registered before) and upload the following documents:

- a) Company's certificate of Incorporation with (CAC)
- b) Company's Registration with Ebonyi State Ministry of Works Contractor's Registration in Category "D" current at the time of the tender
- c) Tender processing fee receipt

- d) List of Plant, Equipment and Technical Staff available for the project
- e) Evidence of Current Tax Clearance Certificate for the past three years
- f) Evidence of VAT Certificate and VAT remittances to Federal Inland Revenue Service
- g) Evidence of similar projects undertaken in the past three years including scope, site of project, contract sum and evidence of successful completion of the project
- h) Evidence of current Audited Accounts of the company for the last three years
- i) Evidence of financial capability and bank reference

#### v. <u>METHOD OF SUBMISSION</u>

Technical and Financial Bids must be submitted from the Contractors' dashboard in the Ebonyi State E-Procurement System before the Bid submission deadline of 1:00PM on Friday, 28<sup>th</sup> February 2025.

#### vi. <u>GENERAL INFORMATION</u>

- a) The Ministry may verify any or all the claims made by applicants and shall disqualify any company whose claims are found to be false.
- b) contractors who have worked for the ministry and have history of poor performances, abandonment, termination and/or prolong contract period need not apply.
- c) Contractors who have capacity and capability to commence and complete any of the projects before payment is scheduled, are requested to state it clearly in the building document.
- d) Non-compliance to the instructions will lead to disqualification.
- e) Bid Documents in English will be obtained from the **Ebonyi state e- Procurement system** (<u>www.ebonyieprocure.eb.gov.ng</u>) after completion of registration and Tender fee payment on the portal.
- f) All bids will be submitted through the E-Procurement system as mentioned above before the bid submission deadline by 1:00PM on Friday, 28th February 2025 Nigeria time. Late bids will not be accepted by the system.
- g) Bids will be opened virtually shortly after the close of tender on Friday 28<sup>th</sup> February, 2025 at 1:00pm.
- h) Any prospective bidder from their dashboard messaging tool, may ask the procuring entity to provide explanations as to the content of the tender document from now till 24hrs to the deadline period for the submission of tenders as of the date of tender notice publication.
- i) The Council is not bound to accept the lowest or any tender.
- j) Bidding will be conducted in accordance with the Law governing Public Procurement.
